

## 2019 Summer School @ Northbrook School District 28

The Northbrook 28 Summer School Program offers a wide variety of enrichment opportunities for students that will be entering 1st through 8th grade. We are offering four class periods of summer school and all classes will be 55 minutes in length. **Please note: your son or daughter should be enrolled in classes that reflect the grade he or she will be entering in the 2019-2020 school year.** For example, if your child is currently a 3rd grader, you would enroll him or her in classes designated as a 4th grade class. Summer school registration will be open to residents of Northbrook School District 28 on March 8 at 7:00am before opening up to District 27 & 31 on March 25 at 7:00am.

2019 Summer School Program will take place at Westmoor School for early childhood program & grades 1- 4. Grades 5-8 will attend Summer School at Northbrook Junior High. The programs are running at separate locations to alleviate traffic concerns and allow for more class programming by grade levels.

Classes begin Monday, June 10, and continue through Wednesday, July 3. These dates are subject to change if additional emergency days are used in the district. The cost per class is \$105 and some classes have additional lab fees.

You will find the online registration link on our District website under Programs/Summer School. Click the "button" on the page and it will connect you to Active Network. Registration will begin for District 28 on March 8 at 7:00 a.m. and ends for all students on Thursday, April 18 at noon. ***Tuition is refundable in the case of class cancellation.*** If you need assistance, please contact Lisa Tenuta (847) 504-3425 or e-mail @ [summerschool@northbrook28.net](mailto:summerschool@northbrook28.net). Some classes are very popular and fill up fast, so please register as soon as possible.

Classes marked with an \*asterisk in Period 4 are designated as a "snack" class. Your child can bring a snack into those classes. We cannot guarantee an allergy-free environment. Due to student allergies, we are requesting that children refrain from bringing any peanut products to summer school, including peanut butter sandwiches, granola bars, trail mix, etc. If your child is not enrolled in a "snack" class, you may not bring food into school. Please see our District 28 snack guidelines for more information.

**If your child will be absent from summer school, we request that you notify the summer school office by emailing [summerschool@northbrook28.net](mailto:summerschool@northbrook28.net) or by calling 847-498-7920 and leaving a message at any time. Attendance is taken in each class period and your help with this will ensure that all students arrive to school safely.**

Throughout summer school, **photos and/or videos of students** are included in District publications and electronic media. If you do not want your child to be featured in these types of pieces, please notify the D28 Communications Director, Terry Ryan in writing before the beginning of summer school.
